BC TRANSIT ADS URGE EVERYONE TO GET TESTED

HepCBC had the first hepatitis C bus ad campaign in Canada in 1996 (urging everyone to GET TESTED for hepatitis C!), and a couple more bus ad campaigns in the years that followed. This year is our largest bus ad campaign ever – it will last the entire month of July and involve bus ads - both inside and outside the buses - in 7 British Columbia cities: Kelowna, Nanaimo, Prince George, Richmond, Surrey, Vancouver, and Victoria. We are doing outreach to the City Councils and Mayors of these seven cities, urging them to proclaim July 28th as World Hepatitis Day in their city, to take photos with the bus ads (see below), and for as many as possible to get PUBLICLY TEST-ED for hepatitis C – see article about this in this issue.

Initiatives for Medicines, Access, and Knowledge (I-MAK), an international leader in patient treatment access and pricing issues (http://www.i-mak.org). Cheryl talked first about how HIV/HCV co-infected people, due to the success of HAART therapies for chronic HIV, are now dying less often from AIDS and more often from HCV-related causes, and in need of increased HCV treatment and support. Then she presented current prevalence statistics (from the Canadian Communicable Disease Report CCDR: Volume 40-19. December 18, 2014) which HepCBC uses in educational presentations about who has hepatitis C in Canada, what their needs are, and how to reach those who don't know they have

The CCDR report presents a more complete picture of the HCV epidemic among users of IV drugs; their research divided these people into current users and former users (including even one-time users.) While the incidence of new infections is now driven primarily by current IV drug users, the people who have hepatitis C in Canada (prevalence of the disease) are not primarily current IV drug users. The 220,000 or more people with HCV in Canada are made up of 35% people born outside Canada who generally contracted the disease through the medical system in their home countries, 23% who once used IV drugs but no longer do, 20% current users of IV drugs, and 15% born in Canada who never used IV drugs.

The needs of the approximately 80% of HCV+ Canadians who no longer use, or never used, IV drugs are very different from those of the IV drug users who are still transmitting and contracting this disease. The first, generally older, group requires a (one-time) screentreat-cure strategy, while the second, generally younger, group is primarily in need of prevention strategies such as harm reduction and regular surveillance, plus intensive services to combat related issues of homelessness, joblessness, hunger, and addiction.

Cheryl's invitation to the AIDS service organizations and others in attendance to cooperate with HepCBC in addressing (speaking with one voice about) HCV and HIV-related issues was warmly received by the participants.

Dear Ms. Plummer:

I am pleased to respond to your letter concerning hepatitis C screening guidelines, which was forwarded to me by Mr. Murray Rankin, Member of Parliament for Victoria.

As you are aware, the Public Health Agency of Canada recommends screening for individuals with risk behaviour and potential exposures to hepatitis C. The Agency is aware of calls to add one-time screening for specific birth cohorts, and has determined that further analysis is required before proposing changes to the current guidance. This additional analysis will include a review by the Canadian Task Force on Preventive Health Care, an independent body of primary care and prevention experts. The Task Force's review is expected to be made public in spring 2016.

In the meantime, the Agency is working with the provinces and territories to increase awareness and promote screening among those at an increased risk for the hepatitis C virus.

The federal government is committed to continuing to work with provincial and territorial partners to address the burden of hepatitis C through the Hepatitis C Prevention, Support, and Research Program. The program funds community-based projects aimed at preventing the spread of viral hepatitis and improving the lives of those infected with the virus.

I hope that this information is helpful in addressing your concerns.

RE: MINISTER'S REPLY

About Federal Minister of Health Ambrose's Reply to HepCBC

In February, 2015, HepCBC sent a letter to federal Minister of Health, Hon. Rona Ambrose, inquiring about the release date of the new hepatitis C Testing Guidelines which would presumably include one-time, agecohort-based (sometimes called Boomer") testing in addition to the current risk-based testing. These new guidelines were widely expected to be released late 2014 or early 2015. The Minister replied that the Guidelines' release has been postponed until spring 2016 because "further analysis is required before changing current Guidelines." The Canadian Task Force on Preventive Health Care (http://www.canadiantaskforce.ca) has been charged with this task. At present hepatitis C is not listed as a pending project on their website.

HepCBC is greatly dismayed by this delay, during which more Canadians will be dying unnecessarily of undiagnosed HCV, while a redundant and unnecessary statistical analysis double-checks figures already published in a Canadian peer-reviewed journal, the Canadian Medical Association Journal of January 12, 2015 which shows that testing the cohort 1950–1970 would be cost-effective by preventing morbidities and mortality in now-undiagnosed Canadians (http://www.cmaj.ca/content/early/2015/01/12/

cmaj.140711.full.pdf) and echoes a parallel "Baby Boomer Testing" campaign now being promoted in the US by the Centers for Disease Control and Prevention (CDC) and the US Preventive Services Task Force, based on the following recommendation of the American Association for the Study of Liver Disease and the Infectious Diseases Society of America: "One-time HCV testing is recommended for persons born between 1945 and 1965*, without prior ascertainment of risks *regardless of country of birth." While HepCBC realizes testing Canadians in the 1945-1950 age group may not be as costeffective as the other years, we have noted many of our members were born in that 5year period, and are now experiencing morbidity and mortality from severe liver disease. Hence, HepCBC joins the Canadian Liver Association (http://www.liver.ca/ landing-page/Hep C PR2013.aspx) and the Canadian Association for the Study of the Liver in recommending one-time testing for the **1945–1975** birth cohort.

An interesting note: the proposed age-cohort testing would identify most of the stillunknown victims of the Canadian blood scandal, who may be eligible for compensation. HepCBC is aware of recently-diagnosed victims such as one who acquired HCV in 1982 (diagnosis 33 years after infection) from a transfusion she did not know she'd had. Canada's blood safety was not secured as HCVfree until 1992-93. Unless age-cohort testing is implemented, new victims could even be discovered as late as 2025 - or even beyond, particularly as infected children of undiagnosed victims may still contract the disease.

Mayors and City Councillors Get Publicly Tested for Hep C!

On Mon. June 22, the mayor and a city councillor in Nanaimo became the first municipal leaders in Canada, to our knowledge, to get publicly tested for hepatitis C. Nanaimo Mayor Bill McKay and Councillor Wendy Pratt accepted HepCBC's invitation to demonstrate that anyone can have hepatitis C and that everyone, particularly Baby Boomers, should be tested at least once. This sort of courageous leadership is helping normalize and de-stigmatize hepatitis C testing, helping publicize that taking an HCV test is a positive step. They have joined the ranks of these other BC political leaders who have "rolled up their sleeves" for a public hepatitis C test: Official Opposition Health Critic and MP Murray Rankin plus MLAs Ralph Sultan, Naomi Yamamoto, Simon Gibson, Scott Fraser, Carole James, George Hevman, Maurine Karagianis, Lana Popham, Jennifer Rice, Harry Bains, Katrine Conroy, Gary Holman, and Jenny Kwan. NEW TREATMENT **GUIDELINES**

New EASL Treatment Guidelines

In July 2015, the EASL (European Association for the Study of the Liver released its HCV Manifesto re-issued, now in French http://hepcbc.ca/wp-content/uploads/2014/11/ new hepatitis C testing and treatment guidelines. Highlights can be found here: The HCV Manifesto was written in rewww.natap.org/2015/EASL/EASL 155.htm The Guidelines can be downloaded from www.easl.eu/ clinical-practice-guideline

In Canada, similar guideline updates are

released by the Canadian Assn. for the Study of the Liver (CASL) whenever changed conditions, new research or new treatments make this necessary. The most recent CASL guidelines are available www.hepatology.ca/wp-content/ uploads/2012/06/16644 myer.pdf. Just because a treatment regimen is recommended by these professional physician specialist organizations does not mean it is covered by a provincial or territorial pharmacare, however, and often additional exclusionary criteria such as a current requirement of many provinces to produce proof of extensive liver damage (F2 or greater) is imposed on those seeking treatment. HepCBC opposes the imposition of any such restrictions, but particularly those not recommended in current CASL guidelines.
